



GUIDELINES FOR REFERRAL TO EDEN SCHOOL

Please note that submission of application does not guarantee admission. Admission is based on the outcome of a suitability assessment by Eden School's psychologists, careful review by the Admissions & Review Committee, and the availability of sufficient physical and trained teaching resources.

APPLICATION CRITERIA

1. **Nationality**
 - a. The child needs to be a Singapore Citizen (SC) or Permanent Resident of Singapore (SPR).
 - b. A child who does not hold SC or SPR status may apply for admission to EDEN SCHOOL subject to the following Ministry of Education's terms and conditions:
 - I. Admission will be on a case-by-case approval basis from the Ministry of Education, subject to the student being issued with a Foreign Student Pass by the Immigration Department;
 - II. Foreign disabled students will pay full fees, which is 4 times the per capita cost for the year
2. **Age**
 - a. In the year of admission, the child has to turn 7 years old and not exceed 14 years of age.
3. **Diagnosis**

Autistic Spectrum Disorder (ASD)

 - a. The child needs to be diagnosed with Autistic Spectrum Disorder (Mild to Moderate Severity).
 - b. This should be supported by a diagnostic or psychological report or written statement from a certified psychologist.
4. The child must be able to work in a group of at least 3 students in a class.
5. **Psychological and Medical Assessments**
 - a. The psychological assessment should not exceed two years from the date of application.
 - b. The medical assessment should not exceed one year from the date of application.
6. **Self-Help Skills**
 - a. At the time of admission into Eden School, the student should be independent in toileting and mobility.



REQUIREMENTS FOR APPLICATION

Application for admission into EDEN SCHOOL must be accompanied by the following documents:

1. EDEN SCHOOL's Application Form
2. EDEN SCHOOL's Medical Report (completed by a medical practitioner)
3. Photocopy of child's Birth Certificate / Singapore Permanent Resident Re-entry Document
4. Psychological Report (completed within two years from the date of application).
The report must include the following :
 - a. Results of the child's individually administered intellectual assessment that present an overview of the child's general cognitive/intellectual functioning. The results should include **verbal, non-verbal** and **global scores** and subtest scaled scores. If specific IQ scores are not obtained, reasons should be provided and any alternative assessments should be documented. Language(s) used during testing is (are) to be indicated.
 - b. Results of the child's adaptive/social functioning as measured by an adaptive behaviour assessment. The child must have significant limitations in at least two of the following areas: communication, self-care, home-living, socialization skills, use of community facilities, self-direction, health and safety, functional academics and leisure and work.
 - c. A summary of the child's individual educational needs.
5. Where applicable, the application should also include a report from the child's current class teacher, previous school reports and copies of examination scores.
6. Where applicable, the application should also include progress reports and recommendations from professional staff working with the student (e.g. Speech Therapist, Occupational Therapist).
