### **School Move**

Yesterday was the official date for the handover of the new building to the school management. The staff, together with the autism consultants from the Autism Resource Centre (Singapore), have been working very hard since March to comb the new building, plan the physical structures and visuals needed and furnishing the various rooms in the school.

A short 45 minutes orientation at the new school has been planned for all our students, scheduled for Wednesday, 26 May during curriculum time. The students will take a short familiarization tour covering the common areas that they will be using when they start school at the new premises.

The school will officially move on 23 June and will start operations at the new premises on 6 July.

### **Parent Teacher Meeting**

School will function as usual for Term 2 up to Wednesday, 26 May 2010. School will close on Thursday, 27 May 2010 for the Semester 1 Parent Teacher Meeting. Your child's class teachers will arrange a 1-hour session with you where they will update you on your child's progress, the focus for the next semester and the holiday homework package for the coming June vacation. ## A Very Special Walk @ Pathlight School


